### **CITIZENS' PARTICIPATION**

Kelly Prilla 219 Magnolia Street, thanked the secretary for her prompt action with dealing with Penn Dot regarding the "sink hole" issue on Spur Road. She also feels the secretary should be able to get the 30 hours a week that council keeps tabling.

James Malloy 128 E Schwab, stated there are several ground hogs, skunks and raccoons around, he was advised to call Xpel. He also stated people keep putting their garbage out too early and the critters are tearing the bags open spewing garbage all over. He stated there are 2 houses on River View that is overgrown, Rich advised those are vacant houses and the borough is not able to locate the owners or executives of the homes and the borough is not able to do anything with the properties. James asked how may police we have on staff, he was advised 3 including the chief.

Bob Silvasy 155 Magnolia Street, he wanted to advise of the kids selling water at Mifflin & Whitaker Street, they are stopping traffic running out in the middle of the road. They leave all of their trash out there and do not clean up after themselves. He was advised that Chief & Randy both have run them off. Bob gave kudos to the public works department for all of their hard work. Bob stated there is a lot of damage happening at the ball-field, damage to the tables, the playground, the dugouts, etc. The gang box was left open for the ball team to put the bases away so they aren't stolen at the end of their game, this was for a time frame of no more than an hour and in that time frame someone took the hammers out of the gang box and damaged the dug out benches and poles, Bob wants to know if police could patrol once in a while, he feels police presence will elevate some of the vandalism. Council stated Community Cares should have someone down there to watch for the vandals, Bob state they do not have enough volunteers. Bob asked if one of the council members could go and sit down there and wait until the team shows up. Mike Bogesdorfer stated no, that is a WCC issue not a council issue. Division was made between the Borough & WCC. Mike Bogesdorfer stated we don't have the officers to go over there all of the time, Bob stated he is not asking for all the time but once in a while would be a great help. WCC has over 600 man-hours of volunteers this year and WCC not the borough paid \$1000 each for the tables and every 2 weeks there is damage to them. Bob is just asking for some help. Bob advised there is a Stat Med Vac training Thursday August 15, 2024, from 7pm - 8 pm, it will involve surround volunteer fire companies, they will be landing in the outfield at the ball-field and WCC has given their consent. Dan Urban stated that the ball-field is designated as a landing zone and is the safest place for Whitaker & the surrounding areas for Med Vac situations. Bob also thanked council for their generosity of the \$1000 donation, however they are canceling Community Day on the September 28, 2024 due too lack of volunteers so council can reallocate the funds. Hoping to be able to draw more people in to volunteer. Bob asked about the restrooms at the ball-field and offered his knowledge and skills to lend another set of eyes on the plans. Rich Lassige advised right now they do not like the plans. Council wants the existing bathrooms torn down, the engineering has just as add on and that is not what council wants.
